

ZOUK STATION PARTICIPANT WAIVER & CODE OF CONDUCT

Zouk Station 16.0 – January 23–27, 2026

Railway Barracks, Goulburn (NSW)

1. Code of Conduct

- I agree to treat all participants, instructors, DJs, and organisers with respect, courtesy, and consideration.
 - I will communicate openly and maturely, both on and off the dance floor, and understand that dance is a shared activity requiring consent and awareness of others.
 - I will not engage in harassment, bullying, excessive noise after hours, or any behaviour that disrupts the comfort or safety of others.
 - I understand that photography and video are permitted in common areas but not in bathrooms or sleeping quarters.
 - By attending, I consent to photos and videos of me being used for Zouk Station promotional purposes.
 - I understand that organisers reserve the right to refuse entry or remove any participant who breaches this Code of Conduct, without refund.

2. Health & Safety Acknowledgement

- I acknowledge that I am voluntarily participating in dance, yoga/stretch, and related movement activities.
 - I confirm that I am in good physical condition and not aware of any medical or physical condition that would prevent safe participation.
 - I accept responsibility for my own health and safety during the event and will immediately inform organisers of any injury or health concern.
 - I understand that Zouk Station is not a medical or therapeutic environment and that professional health or mental health support is not available onsite.

3. Insurance & Coverage

- I understand that Zouk Station holds an active Dancesurance Showtime Liability Policy (Policy No. BXLC-DCL-2025-011611) issued by XL Insurance Company SE (Brooklyn Underwriting), providing Public Liability and Professional Indemnity coverage for the event.
 - This insurance covers event activities organised by Zouk Station, including workshops, socials, and performances, but does not cover personal belongings or personal accident/medical expenses.
 - I accept that I am responsible for my own personal property and health insurance.

4. Risk Warning & Waiver

- In accordance with Section 5M of the Civil Liability Act 2002 (NSW), I acknowledge that participation in dance and movement activities involves obvious risks, including the risk of physical injury.
- I voluntarily assume all such risks and accept responsibility for any injury or damage I may sustain while participating in Zouk Station 16.0 activities.

- I release, waive, and discharge Zouk Station organisers, instructors, DJs, team members, volunteers, and the venue (“the Releases”) from all liability for personal injury, property damage, or loss arising from my participation, except where such liability cannot lawfully be excluded.
- Nothing in this waiver limits my non-excludable rights under the Australian Consumer Law.

5. Accommodation & Age Policy

- I acknowledge that minors (under 18 years) are not permitted to stay in the onsite accommodation.
- Any minor attending daytime activities must be accompanied by a parent or legal guardian, who must sign the waiver on their behalf and remain responsible for their supervision.

6. General Terms

- Governing Law: This Agreement is governed by the laws of New South Wales, Australia.
- Severability: If any part of this Agreement is found invalid, the remainder remains enforceable.
- Acknowledgement: I have read and understood this Agreement and sign it voluntarily.
